कृपया उपरोक्त विषयक निवेदन है कि मा0 राष्ट्रीय हरित अधिकरण, नई दिल्ली में विचाराधीन ओ0ए0 सं0- 1002/2018 अभिष्ट कुसुम गुप्ता बनाम स्टेट ऑफ उत्तर प्रदेश व अन्य तथा ओ0ए0 सं0- 827/2024 में दिनांक 24.07.2026 को निम्नवत् आदेश पारित किया गया है-

"...1. A letter has been circulated by the counsel for the Respondent No. 1 seeking adjournment for filing the compliance affidavit. Prayer is allowed.

2. Shri Pradeep Mishra, learned counsel appearing for the UPPCB has submitted that Civil Appeals No. 8547-8548/2022 in the matter of New Okhla Industrial Development Authority v. State of UP & Ors. is pending before the Supreme Court against the order dated 03.08.2022 passed in OA No. 1002/2018 and against the order dated 05.09.2022 passed in the review application. He has further submitted that Hon'ble Supreme Court by the order dated 21.05.2026 passed in the above Civil Appeals has constituted a committee headed by the Union Home Secretary for preparing a comprehensive Yamuna Action Plan within eight weeks. In the said background, he has made a

prayer for adjournment by submitting that he will update the Tribunal about the pending proceedings before the Hon'ble Supreme Court.

3. At this stage, the Applicant has referred to paragraph 15 of his final submissions on page 3534 and has submitted that he has filed the detailed representations dated 30.07.2025 and 10.07.2026 against dumping of the municipal solid waste and construction debris in and around the in-situ wetlands at Sector 137 and 49, Noida. But the said representations have not been considered till now.

4. Member Secretary, UPPCB is directed to ensure that the NOIDA Authority takes appropriate action on the above representations failing which the needful will be done by the UPPCB. Learned counsel for the NOIDA Authority submits that if the Applicant gives additional copy of those representations to him, he will ensure appropriate remedial action by the NOIDA Authority.
